FROM PRESIDENT BOYER'S DESK

Enjoy a Safe and Happy 4th of July!

Please consider your neighbors and neighbors' pets this July. The lead up to any celebration with **fireworks**, such as July 4th in particular, can be a very traumatic time for many **dogs**. The loud bangs and flashes created by fireworks are often very frightening for them, making them stressed and unpredictable, potentially putting their safety at risk. Additionally, fireworks can cause damage to pool cages and create litter that's not picked up from fireworks that were carelessly used. Please be considerate to your neighbors and community dogs! Avoid shooting up large exploding fireworks. Finally, the Independence Day Holiday falls on Monday, July 4, and this will affect and move residential collection schedule one day later to Friday, July 8th.

HOA Rules and Regulations - Rules 19 and 20: Our community Rules and Regulations prohibit the overnight parking of Commercial vehicles with business signage or equipment used for business; trailers; or any

recreational vehicles at the clubhouse, in your driveway or on any street. Here's what our rules 19 & 20 say:

19. No commercial vehicle (including vans used for commercial use and vehicles displaying commercial signage), truck (as defined by the Florida Department of Highway Safety and Motor Vehicles and/or by common usage and practice, not including light pick-up trucks of three-quarter (3/4) ton capacity or less, less than twenty (20) feet in length, and used for non-commercial purposes). unlicensed or inoperable motor vehicle (which shall include, without limitation, any vehicle which would not pass applicable state inspection criteria), vehicle without current tags or registration, trailer, mobile home, camp truck, house trailer, recreational vehicle, boat, jet ski or other similar vehicles, machinery or equipment of any kind or character (not including such equipment and machinery as may be reasonable, customary and usual in connection with the use and maintenance of any home and any equipment and machinery as the Board of Directors may require in connection with the maintenance and operation of the Association) shall be kept within the community, , unless such vehicle is parked inside the garage of the home. For purposes of this rule, the term "kept" shall mean present in the community for either four (4) consecutive hours or four (4) hour total during any twelve (12) hour period.

20. No vehicle with any sign, advertising and/or commercial writing or lettering or other similar writing and/or letter, whether business/commercial related or otherwise, shall be kept in the community, unless the vehicle is parked inside the garage of a home. For purposes of this rule, the term "kept" shall mean present in the community for either a period of twelve (12) hours or overnight, whichever is less.

Clubhouse Pool and Spa are Closed after dark!

There have been reports of people seen using the pool or spa after dark. This is NOT permitted by Lee County and there is very clearly posted signage stating this fact. Do not let your children or guests use either the pool or the spa after dark. If this becomes a larger problem by homeowners breaking the rules, the Association will need to take an action which could include fines or adding expensive gate locks and monitoring equipment.

July Landscape Scheduling

Weekly landscaping services this month will include turf fertilization, shrub fertilization, mowing, edging, blowing and monthly weed removal from flower beds. Shrubs and hedges will be trimmed as needed. Irrigation checks are done every month. If you have any concerns regarding your own landscaping, such as irrigation repairs needed, please contact the Estate Landscaping office directly by phone at 239-498-1187 and be sure to give them your address and problem specifics. May 2022 YTD HOA Financial Results

Our HOA Total Revenue so far this year - May YTD was \$274,946. Our Total Expenses May YTD were \$283,392, meaning expenses have exceeded revenue by \$8,446. Association Reserve Accounts held to use for future capital repair or replacement items currently total \$339,162 which is an increase of 7% over last year. All Reserve funds are held in FDIC insured bank accounts or CD's.

ARBs - Architectural Review Board Approvals

ARB approvals are needed before starting to replace roof tiles, painting a house, installing a new swimming pool, removing a tree, or making any exterior change to the home or property. The ARB rules are contained in the Rules and Regulations that can be found on our website or Owners Portal if you don't have a copy. Please read the ARB rules before filling out the ARB request form which includes attaching all the required documents and information. Once you have prepared your ARB request, please deliver this to Charlie Kelly, our volunteer ARB Chairman. He has many years of experience and knows how to process your request. His contact information can be found in every monthly newsletter, including this one.

Please note:

- 1. If you need a new gate entry code, clubhouse replacement key card or entry gate clicker, contact me at gboyer01@aoi.com or 239-415-1633. There is a \$10 charge for purchase of clubhouse cards and \$20 for gate clickers.
- 2. Mailbox repairs and replacements are included and made by the Association. Contact me for any needed repairs.
- 3. Cars parked overnight on our neighborhood streets will be towed at the owner's risk and expense without warning. Please keep vehicles in your garage or driveway and off the streets between midnight and 6AM.
- 4. Before making **ANY** changes to the **EXTERIOR** of your home or yard, including landscaping additions, painting, pools, etc., please obtain prior approval by the Architectural Review Board. The ARB guidelines can be found in the rules package on the community website www.mycasadellago.com.

Keep Street Gutters Clear to Prevent Flooding

During the rainy season, we need the street gutters kept clear so the rainwater can wash into the drains and then into the lake. Do not put trimmings or palm fronds in the gutters or on top of storm drains! Leave these on your lawn to be picked up by the waste collectors or landscaping crews.


